MINUTES: Motion: Mercer/Youden resolved that the minutes of our last regular meeting held on November 3<sup>rd</sup>, 2015 be adopted as circulated. In Favour 5; Opposed 0; Carried.

Mayor Rodway on behalf of the Department of Municipal and Intergovernmental Affairs presented our Deputy Mayor, Ralph Trickett, with his Certificate of Recognition for 16 years of Municipal Services. Councillors & Staff congratulated DM Trickett on his achievement.

#### COMMITTEE REPORTS

Mayor Rodway, Chair of the Finance Committee, presented the 2016 Municipal Budget to Council and reported that due to this being a reassessment year the percentages of values are gone up on average of 50% for the Town. The finance committee which consist of DM Trickett & Councillor Hiscock along with staff was pleased to announce that there would be a reduction in the mill rate by 1.6 mills lowering our rate to 4.4 mills. There are no changes to the permits or water & sewer rates. Chairperson Rodway noted that a Vendor Permit will come into affect January 1<sup>st</sup>, 2016 at a rate of \$50.00 per year. There are no other changes made to our tax structure. Also noted that there is money allocated in the budget to continue work on the lighthouse trail and our playground. Chairperson Rodway stated that we have a balanced budget for 2016 in the amount of \$796,546.03

Motion: DM Trickett/Mercer resolved that our 2016 Municipal Budget be accepted and approved as presented. In Favour 5; Opposed 0; Carried.

Motion: DM Trickett/Mercer resolved that Municipal Tax rates for 2016 be accepted and approved as presented with interest charges of 12% annually. In Favour 5; Opposed 0; Carried.

Motion: DM Trickett/Youden resolved that we borrow from the Bank of Nova Scotia for the year 2016, Forty Thousand Dollars (\$40,000.00) as our operating line of credit. In Favour 5; Opposed 0; Carried
