NEW BUSINESS

The Town Clerk/Manager reported that Phase 3, Farm Road Water & Sewer should be starting around the end of October. It was noted that Imperial Excavating Ltd was awarded the contract in the amount of \$187,922.65. Out of the \$179,078.50 remaining it was agreed to continue on with the sewer line on CB Highway. Our Town Engineer is also looking to see if the cost of upgrading our sewer station on CB Highway could be covered.

After discussion on Capital Works for 2019 the following motion was made.

Motion: Trickett/DM Broughton resolved that we apply for Capital Works for 2019 making Priority #1 CB Highway and Priority #2 to upgrade to water intake In Favour 4 Mayor Rodway, DM Broughton, Councillors Trickett & Brown; Opposed 1; Councillor Matthews

DM Broughton on behalf of Councillor Wall raised the issue of Bus Shelters. Council members noted that the bus shelters we had previously either got destroyed, set on fire along with residents requesting to have them removed. It was agreed by council not to install bus shelters.

Motion: Trickett/Matthews resolved that our meeting be adjourned until November 6th, 2018. In Favour 5; Opposed 0; Carried. Time: 10:04 p.m.
