Minutes of a regular meeting of the Council for the Town of Brigus in the Town Hall, December 6th, 2011 at 8:05 p.m.

MEMBERS PRESENT: Mayor Byron Rodway, Deputy Mayor Ralph Trickett, Councillors; Lorne Youden, Greg Hiscock, Faith Roberts-Pike, Pauline Mercer and Roy Clarke.

MINUTES: Motion: Roberts-Pike/Mercer resolved that the minutes of our last regular meeting held on November 1st, 2011 be adopted as circulated. In Favour 7; Opposed 0; Carried.

Before the meeting started Mayor Rodway and Council Members welcomed our newest Councillor Mr. Roy Clarke to our Council Chamber. C. Clarke won by Acclamation on Nomination Day held on November 8th, 2011. The Clerk/Manager noted that C. Clarke was sworn in on November 14th, 2011 during our orientation meeting.

A moment of silence was held for David Percey who died suddenly on November 26, 2011. David was an active member of the Brigus Volunteer Fire Brigade for over 27 years.

Motion: Youden/DM Trickett resolved that the application received from 1-5 Antle's Beach - Wharf be approved . In Favour 7; Opposed 0; Carried.

Mayor Rodway, Chair of the Finance Committee, presented the 2012 Municipal Budget to Council and reported that the finance committee is pleased to announce that the tax rates will remain the same with no reduction in services. Chairperson Rodway noted that no other changes were made to our tax structure. Also Chairperson Rodway stated that we have a balanced budget for 2012 in the amount of \$658,764.00

Motion: DM Trickett/Roberts-Pike resolved that our 2012 Municipal Budget be accepted and approved as presented, along with attached rates and interest charges of 12% annually. In Favour 7; Opposed 0; Carried.

Motion: DM Trickett/Clarke resolved that our Policy Manuel be amended under "Sick Leave" allowing an employee to carry forward a maximum of 36 days, Under "Holidays 1-5 Years 2 weeks, 6-15 years 3 Weeks, 16-24 years 4 Weeks, 25 plus years 5 weeks, Under "Bereavement" add Departments of Council. In Favour 7; Opposed 0; Carried.

Motion: DM Trickett/Hiscock resolved that we borrow from the Bank of Nova Scotia for the year 2012, Forty Thousand Dollars (\$40,000.00) as our operating line of credit. In Favour 7; Opposed 0; Carried
