The flooding doesn't happen all the time but if you get a heavy rain fall in a short time then we are flooded along with our basement. Council noted that they would like to see what is happening there so they can make the right decision on what to do to correct the problem. It was agreed that the Clerk/Manager would check with our engineers for their input along with getting cost on replacing the culvert with larger ones or a bridge.
