GENERAL BUSINESS

1. Councillor Roberts-Pike sent an e-mail stating that she has started work on the Towns Emergency Plan.
2. Shane Sparkes to attend Water Course in St. John's on July 13, 14, 15, 2010
3. Apply for Community Enhancement Project to do trail to First Pond and River Cleaning.
4. Works Committee to meet to look at Washrooms for our Fire Brigade.
5. Council members to review Town Plan regarding concerns that need to be addressed for the Municipal Plan review.
6. Finance Committee to look at our rental fees for equipment.

Councillor Mercer raised the issue on amending our policy on "Sick & Bereavement" to include retired employees.

After discussion, Council agreed to leave our "Sick & Bereavement" as is.

Councillor Hiscock & C. Mercer presented Council with a drawing for the Towns Welcome Signs. It was agreed to get more information on the signs before Council accepts which one to go with.

Motion: DM Trickett/Hiscock resolved that we write Mr. Ken Kelly, Chair of Eastern Waste Management and advise him that Council is prepared to be part of the Tender Process for waste collection for this area. In Favour 6; Opposed 0; Carried.

Councillor Youden left the meeting due to a Conflict of Interest.

The Clerk/Manager informed council that he had received a letter from a lawyer concerning title to land on Keating's Road. A discussion was held regarding the way the boundary line of Brigus/Cupids runs on Keating's Road and it was agreed that we set up a meeting with members of the Cupids council to discuss the issue of the boundary line.

Councillor Youden returned to our meeting.

DM Trickett reported that they have met with Mr. Dave Hiscock regarding the boundary lines for the War Memorial and now know the boundary. It was agreed we meet with members of the Legion to discuss the work that is to take place around the War Memorial.

Councillor Youden noted that one of the things outlined in our ICSP Plan was if we needed the Town Hall considering we already have another building. It was agreed by Council to look at our public building and to analyze the cost of selling our Town Hall versus moving to our Public Building.

Councillor Youden expressed interest in becoming a member of the Landfall Trust Advisory Committee.

Motion: Hiscock/Fowler resolved that we appoint Councillor Youden to the Landfall Trust Advisory Committee. In Favour 5; Abstaining 1, (C. Youden), Opposed 0; Carried.

Motion: DM Trickett/Youden resolved that our meeting be adjourned until August 03/10. In Favour 6; Opposed 0; Carried.
