Minutes of a regular meeting of the Council for the Town of Brigus in the Town Hall, March 6<sup>th</sup>, 2012 at 8:05 p.m.

MEMBERS PRESENT: Mayor Byron Rodway, Deputy Mayor Ralph Trickett, Councillors, Faith Roberts-Pike, and Roy Clarke.

MINUTES: Motion: Roberts-Pike /Clarke resolved that the minutes of our last regular meeting held on February 7<sup>th</sup>, 2012 be adopted as circulated. In Favour 4; Opposed 0; Carried.

#### ARISING FROM MINUTES

Regarding the community build program proposed by Philp Evans, it was felt by Council that this would be to much of an expense at this time to proceed.

The Mayor reported that he along with DM Trickett, the Town Clerk/Manger and Town Engineer, Chris Roberts attended a meeting with our MHA Tom Hedderson and the Minister of Municipal Affairs Kevin O'Brien regarding our 2012 Capital works application. The minister was glad to know that we are willing to accept phases over a period of time rather than trying to have the full project now. It was felt that Brigus will get a share of the funding applied for to do Farm Rd in the tune of 1.2 million this year. Also discussed was the parcel of land located at 11-35 School Lane. Letters are to be written from both ministers on behalf of the Town of Brigus asking to forgo any liens that may be held on this property.

The Mayor also reported on a meeting DM Trickett and he had with the Town of Cupids. Some suggestions made pertaining to Youden Place were, Brigus pick up garbage, Cupids do the snow clearing. There was no mention of road maintenance. With respect to the 2 residents who pay taxes in both municipalities it was suggested that each town take one tax payer each. Cupids would not agree to any boundary changes.

Councillor Clarke reported that Landfall Trust was successful in receiving the Manning Award.
